



Changes as of May 10

As we introduced in our previous newsletter, effective May 10 the US Dept of Ed has replaced the FAFSA PIN number with the new FSA ID. The FSA ID is made up of

3 components: the FSA ID, the verified email address, and the case sensitive password. The password and either the verified email address OR FSA ID must be used to access an already submitted FAFSA or submit a new one. This change has been causing a bit of confusion for those who still have updates needed on their FAFSA. Click here for instructions for setting up your FSA ID. Remember, all students and one parent of dependent students will each need the FSA ID. Use our helpful DATA SHEET to record your information but remember to keep this information secure. Of course, call us if you have any questions.

You must complete the Financial Aid forms every year to be eligible for NEED BASED AID - including student loans!

There may be a few steps left...

Make sure you have:



- Formally "Accepted" all forms of aid for which you want to take advantage. Even though it seems obvious, the school will not assume you want the Grant or Scholarship unless YOU tell them!
- Completed the Master Promissory Note (MPN) if you are a first time Federal Student Loan recipient. You will need the FSA ID if you haven't already completed your MPN.
 Click here for instructions to apply for your FSA ID.
- Updated the FAFSA with actual tax return information. The FSA ID will be needed to complete the update. Garretson Financial clients must send copies of their Federal 1040, along with FSA ID information, to our office if you haven't already done so. Not only will we update your current FAFSA, but this makes it easier on you for next year's filing.
- Checked the school's financial aid link on your student's account to make sure there are no outstanding items. An oversight can be costly!
